TEMPORARY CHAIRMAN: Jim Surfield made a motion to appoint Denny Brown as temporary chairman; seconded by Michael Steinbacher; motion carried.

TEMPORARY SECRETARY: Denny Brown made a motion to appoint Jim Surfield as temporary secretary; seconded by Michael Steinbacher; motion carried.

ELECT CHAIRMAN: Jim Surfield made a motion to elect Denny Brown as Chairman of the Board of Supervisors; seconded by Mike Steinbacher; motion carried.

<u>VICE-CHAIRMAN:</u> Denny Brown made a motion to elect Mike Steinbacher as Vice Chairman of the Board of Supervisors; seconded by Jim Surfield; motion carried.

ROADMASTER: Mike Steinbacher made a motion to elect Jim Surfield as Roadmaster with no additional compensation; seconded by Denny Brown; motion carried.

<u>MAINTENANCE SALARY FOR SUPERVISORS:</u> The salary for this will be set by the auditors when they meet Jan. 4, 2017. The results of that meeting was as follows: the hourly rate for supervisors doing maintenance work will remain at \$17.50 per hour.

<u>TREASURER'S BOND</u>: Jim Surfield made a motion to set the treasurers bond at \$400,000.00; seconded by Mike Steinbacher; motion carried.

APPOINT SOLICITOR: Denny Brown made a motion to appoint Denise Dieter of Drier & Dieter Law Offices as solicitor at a rate of \$110 per hour; seconded by James Surfield; motion carried.

<u>APPOINT DEPOSITORY:</u> Jim Surfield made a motion to appoint Jersey Shore State Bank as depositories for Township funds; seconded by Mike Steinbacher; motion carried.

APPOINT SEWAGE ENFORCEMENT OFFICER: Jim Surfield made a motion to appoint SEO Services as the Township Sewage Enforcement Officer; seconded by Mike Steinbacher; motion carried.

<u>**DELEGATE TO STATE CONVENTION:**</u> Denny Brown made a motion to appoint James Surfield as the delegate to the State Convention with expenses to be reimbursed; seconded by Mike Steinbacher; motion carried.

MILEAGE REIMBURSEMENT RATE: Jim Surfield made a motion to set the mileage reimbursement rate at .535¢, as established by the Federal Government for 2017; seconded by Mike Steinbacher; motion carried.

<u>Set Park Rental Rate:</u> Jim Surfield made a motion to set Park Rental at \$40.00 for non-residents and a \$40.00 refundable deposit for township residents with proof of residency (ie. valid driver's license), seconded by Mike Steinbacher; motion carried.
