### Chairman's report – Lynn Hill

There is an agreement for Mutual Aid and ER Assistance for our fire service. Our Solicitor has advised against signing at this time. This will have an impact on our Workers Compensation. The supervisors are suggesting a sit down discussion with Duboistown, South Williamsport and our EMA. The supervisors do not like the idea of someone using our equipment.

Lynn spoke with Graffus and Graffus stopped in to see Kurtz and he said he would return his keys and files.

### **Road Master - Mike Steinbacher**

Its been a busy year so far with the snow. They are doing a wonderful job. They are looking into a better spreader for next year. A discussion about selling the older spreader.

Mike would like to set up a meeting with PennDOT about getting this road done and speak with Pine Creek Township, they will do the tar and chip, since it is another Township that will not need bid. Mike wants to add Hillside to that job. There is a hole starting on that road. They want to get the specs for a bid advertisement very soon.

Mike spoke with Kyle at Light Heigel and will like to have a sit down about the projects. Salt is good. All the supervisors agree the guys are doing an exceptional job on the roads.

## Park Chairman – George Berninger

George explained that he has researched recycle bins for bottles and cans to set at the park. He was looking at getting 4 Green Recycle Containers at a price of \$147.00 each. A discussion about George taking care of the Containers. There was also talk about securing the containers also. Lynn is asking for a motion.

#### **New Business**

At this time the board is opening and acting on the sealed bids for the backhoe. We received 3 bids, Carson Auto Wreckers in Montoursville for \$4,898.79, Mike Veneriano @ \$3,105.00, and Kelli Manchester @ \$5,050.50. The board had discussed running the backhoe through the auction with a reserve of \$6,000.00 but the cost of getting it there and the % for the auction they decided to go with Kelli Manchester at \$5,050.50. She will be contacted.

## **Old Business**

Hill started a discussion regarding the equipment replacement fund. This year the Township had budgeted for \$3,000.00 to be deposited into that account in 2 separate deposits of \$1,500.00 as a contribution. There was a short description of the fund and what it is intended for. At a point in time the board had stopped the deposits. Hill asked for a motion to resume making the deposits and make the first deposit of \$1,500.00 now and we will revisit the finances for the second deposit later in the year.

### Fire Company Report - Mike Steinbacher

The January 2021 report consisted of 10 calls including 1 vehicle accident, 6 medical, 1 domestic assault injury and 2 mutual aid vehicle accidents. There was no training due to COVID-19. 5 members received the COVID-19 Vaccine (1<sup>st</sup> Dose). And there is work being done for a federal grant for Non-Profit Rural EMS.

Hill and Kurtz had asked Steinbacher if the roster is up to date. We need to make sure that is current for our insurance company. Mike will double check at the fire company meeting.
