Graffus also spoke with Susan Steinbacher regarding her neighbor Irv Henninger cutting down trees and diverting water on to her property. Graff went to look and found that he had only cut 3 trees that were dead and it had no impact on the water system. The Township will not intervene with neighbors.

Wolfgang Slagel on Hillside Dr has clean up issues. Graff is trying to have the problem taken care of without a NOV.
