Road Master - Mike Steinbacher

Mike wanted to look into lowering the speed limit on Village Dr from 45 to 35. He will talk to PennDOT regarding that issue and find out what studies need done for that.

Hillside Dr water issue was discussed a little. Light Heigel is not working at this time.

A short discussion was had regarding some new lawn equipment. Mike will get some prices for the next meeting.

Park Report – Lynn Hill

All the poles were tore out at the park parking area and replaced with guardrails.

We had Williamsport Parks and Streets make 6 signs, at no cost to the Township, a service in kind, for park closing dusk to dawn. Placement was discussed. We will get the signs up as soon as they can.

The office was sanitized and disinfected by Erhlich on Friday May 29th.

Lynn received a price from Erhlich for weed spray along fence line, arounf the tennis court, the light poles around the park. You spray 1 time a year and it is good for the whole year. \$556.00. A resident wanted to compare the price of spraying ourselves. This would only need done once. Lynn will set this up.

Lynn will call Denise regarding a waiver for liability against COVID-19 as we open the Pavilions. And Mike will call Jim Pfleegor to get any information from CDC that they are recommending.
